COURSE DESCRIPTIONS

12 Lead ECG Carleton - Take your knowledge further in this pre-conference workshop as you learn how to identify advanced lethal ECG rhythms, helping you positively impact a patient's morbidity and possible mortality. Bring your thinking caps!

Advanced Burn Life Support This eight hour pre-conference workshop is designed for physicians, nurses, therapists, paramedics and other EMS providers. This hands-on training will enhance your ability to assess and stabilize patients with serious burns during the first critical hours following injury, and to identify those patients who meet criteria for transfer to a burn center. Following a series of lectures, case studies are presented for group discussions, and you will work with simulated burn patients to reinforce assessment, stabilization, and transfer criteria. A written exam and practical skills assessment will conclude the workshop, and certification from the American Burn Association will be received upon completion of the course evaluation.

High Performance CPR Sluys - This hands-on pre-conference workshop will cover elements demonstrated to improve outcomes in the treatment of cardiac arrest, including the 10 steps to improve survival, based on the Resuscitation Academy's curriculum on High Performance CPR. Join a motivated group of instructors and students in creating a resuscitation culture of excellence.

2015 American Heart Association Basic Life Support (BLS) Sluys - for Healthcare Providers course includes: Key changes in basic life support, reflecting the new science from the 2015 American Heart Association Guidelines for Cardiopulmonary Resuscitation and Emergency Cardiovascular Care and critical concepts of high-quality CPR. CPR AHA cards provided.

BLS is the New ALS: Why EMS Needs to Rethink the Roles of EMTs and Paramedics Gerber In the past, we often thought of patients as either "BLS" or "ALS." But patients are not one or the other, providers are. Today we realize that many critical patients only need BLS treatments, while ALS assessments may help us find the right care for chronic patients with "minor" problems. This talk will use medical evidence to re-examine how we view the difference between BLS and ALS and how those paradigms are harming EMS today.

Anchors Away: Avoiding Critical Decision Making Errors That Could Harm You and Your Patients Gerber - This talk focuses on cognitive biases and how they influence critical decision making in EMS. Through case studies, we learn the different types of biases, how to recognize them, and steps to prevent them from leading us down the wrong path.

The 'Art' of Professionalism Helbock - Every individual in EMS is in this profession for similar reasons. They are compassionate, motivated, self-starters who want to spend their lives helping others. Many see themselves as 'professionals' but do their peers or supervisors see them that why? COURSE DESCRIPTIONS

Fun at Work Berry - Hey, it's okay to experience joy and fun at work. It makes good business sense. In the world of emergency health care, mixing business with pleasure can play a vital role in boosting morale and productivity among stressed out employees. Bringing humor into the workplace can help bridge the traditional management – employee gap and allow for a more creative and supportive work environment. Join us as Steve offers some amusing techniques to motivate, inspire, and build pride in your coworkers.

Is there an EMT on the Plane? Responding to Medical Emergencies on Commercial Flights Gerber Many of us have been on a flight and heard the call: "Is there a medical professional on the plane?" What you might not know is that commercial airlines are required to carry a limited amount of medical equipment. In this class, we'll learn what that equipment is, the epidemiology of emergencies on commercial flights, and how treating a patient at 30,000 feet differs from treating one on the ground. (Presented at 2014 Virginia EMS Symposium.)

This interactive, dynamic course will cover the latest on pediatric assessment of the sick and injured, as well as teach the components of triage as it pertains to the pediatric patient!

Pediatric SICK/NOT SICK! Helbock - A Guide to Rapid Pediatric Patient Assessment - Rapid assessment and appropriate treatment of the "Sick" pediatric patient can mean the difference between a child that survives and one who does not. Pediatric assessment doesn't need to be intimidating. Learn from the author of the famed "Sick/Not Sick" program on how to use a "triad" of key indicators to quickly assess and decide the correct treatment path. By using the "triangle", pediatric assessment has never been easier!

Mass Casualty Triage: Try adding some SALT Sakata - Triage in times of an overwhelming number of patients is very different from everyday triage, even in today's environment when most emergency rooms and hospitals are full and functioning at capacity. In 2007 a group of trauma experts convened by the CDC developed a new algorithm called SALT (Sort, Assess, Lifesaving measures, Treat/Transport). This talk will discuss the specific challenges of pediatric triage in an MCI and through case studies compare JumpSTART and SALT identifying strength and weaknesses of both.

Toxicology for the 1st Responder Dr. Garrard - will present the emerging drugs of abuse including bath salts and synthetic marijuana, as well as Molly and flakka, e-cigs and others. Management considerations for the EMS community and resources available to them will also be discussed.

EMS Response to Active Shooter "hands on" exercises Almer - This 2 part course provides information to EMS responders on how to prepare for a response to an active shooter incident. Presented by professionals with over a collective five decades of experience in the tactical law enforcement realm, attendees will receive training on tactical concepts and applications, field-tested medical skills and considerations. The morning classroom is open to anyone but must taken to participate in the 4 hour "hands on" exercises that give attendees a foundation for further development of these skills. *Please note that attendees will be expected to be in good physical shape and wear suitable clothing for practical exercises in a tense, rapidly-evolving, dynamic environment. Protective equipment shall be supplied by the instructor cadre as well as safety protocols and expectations.

Home Improvement Trauma Berry - 70% of construction related injuries are week-end warrior types because all you really need is a can of cold beer in one hand and a power tool in the other. Examine some of the most common and uncommon injuries when man fails to stay focused on the task at hand by addressing assessment, care and scene safety. This class is balanced with humor in one hand and a power tool power point remote in the other.

COURSE DESCRIPTIONS

(LVAD) Smith - This session will focus on the Left Ventricular Assist Device (LVAD) now being placed in critically ill myocardial failure patients. Learn about the devices, troubleshooting, and changes to patient assessment and care.

Mental Health Patients Be part of a round table discussion of professionals who regularly deal with the mentally ill. As emergency health care providers, we often contact patients with some type of mental illness, yet many of us receive very little training about it. Learn ways of deescalating situations and keeping ourselves and co-workers safe. As a part of the health care system in our region we want your input as we look for solutions to some of the problems within our emergency health care system. Through this interactive session you will learn the recourses available in the community so patients can get the help they need.

Moulage for Realistic Training Hart - Great benefit is gained through practice that incorporates "victims" that are true to life when training to respond to disasters and emergencies. Having "injury artists" who can help prepare "victims" greatly increases the effectiveness of training. No special expertise is needed to take this class. Limited to 30 participants.

Domestic Violence/Sexual Assault Panel A panel of professionals will explain the various roles and responsibilities of coordinated response to domestic violence/sexual assault incidents to provide pre-hospital care providers the skills to best support victims of these crimes. From dispatch, treatment in the field, emergency department, through support and advocacy, your questions regarding the entire continuum of care will be discussed. Learn how best to interact with victims, how victims may react and respond to care givers, and how responders may contribute to the support system from an informed perspective.

Time Means Brain: Understanding Stroke Sheehy - Motivated by the understanding that "time means brain", EMS providers work hard to provide effective and rapid pre-hospital care and transport. Enhance your role as a major player in Stroke Systems of Care with a greater understanding of the physiology and epidemiology of CVA, and the critical pieces of information which enhance the evaluation and treatment in the ED for improved patient outcomes.

Mythbusters: "No Pain, No Gain", Managing Painful Procedures in Pediatrics Sakata Much of the fear in managing pediatric patients is the fear of "hurting them". And yet, injury and illness is the reason they have come into our care. Much of the previous teaching in pediatrics employed the use of "brutane" (i.e. the "just do it" philosophy of pain management). However, multiple advancements have been made. This 2 hour session will introduce you to a wide array of techniques you can employ tomorrow in taking care of your pediatric patients. We will discuss both non-pharmacologic and pharmacologic tools, review recent literature, and equip you with the techniques you need to help your smallest patients.
